Course Description:

This course will cover the area of family therapy. Emphasis will be given to various theoretical formulations of family dynamics and treatment strategies. The use of family therapy for the treatment of various disorders will be discussed. Special emphasis will be given to the treatment of adolescents and "psychosomatic families". Material presented may include research, theoretical information, actual case histories and videotaped interviews.

Required Text:

Rasheed, J.M et al. Family Therapy. Models and Techniques, 2011

Course Requirements: The course requirements will be the following:

The first section of the course will largely consist of the presentation of relevant background, historical and theoretical information pertaining to family therapy. The first class test will be made up of multiple choice questions and 1 short essay question. (Tentatively Oct 2, 2018, Chapters 1, 2, 11 & pages 479-91, 25 % of final grade).

The second section of this course will involve a more detailed exposure to specific types of family therapy. Video taped family therapy sessions as well a "role play" of a family therapy interview will be presented. The second class test will be made up of multiple choice questions and 1 short essay question. (Tentative date Oct 30 or Nov 1, 2018, Chapters 4, 5, 6, 7 & 10, 25 % of final grade).

The third phase will involve **student seminar presentations**. The amount of time (20 – 35 minutes) allocated for seminar presentations and whether presentations will be done individually or in “pairs” will depend on the number of students in class. This will be discussed in detail during the first 2 weeks of class and on the “seminar preparation day” class (Sept 18, 2018)

Your topic must have my approval (topics and dates are on a first come first served) and must be related to family therapy. The preferred method of selecting a topic is to discuss it with me first and then to e-mail a description of your chosen topic and preferred seminar date. As well, the class on Sept 18, 2018 will be “seminar preparation” day. During this class time, students can meet with me to discuss and choose a topic/partner, choose a date for their seminar, review the outline for their topic, etc.

Seminars will tentatively start on Nov 1 or 6, 2018 and will be marked according to the Seminar Evaluation below (25 % of final grade). **Note:** Each presenter will be marked individually regardless of whether their seminar was presented individually or in “pairs”.

On the day of the seminar, each presenter (or pair of presenters) must provide each student with a **written summary** of their seminar (max 1 double sided page/single spaced including references). Summaries are to be written using full sentences and paragraphs (not point form) with references properly cited in the text (numbers can be used) and with a complete reference list (10% of final grade). **Note:** If your seminar presentation was done in “pairs”, only 1 summary for the “pair” is required and both students will receive the same mark for their summary.

The summaries may not be merely a written version of your oral presentation. The summary is designed to compliment your in class presentation. This will further be discussed in class. For the summaries, the administrative assistant in the Psychology Office will provide you with access to the photocopier.

**Seminar Info: Seminar presentations will be conducted individually or in “pairs” (see above)**

**Length:** Tentatively, each presentation will be allotted a total of 20-35 mins (see above, includes time for questions)

**Powerpoint:** It is required that your presentation be a “Powerpoint Presentation” (or equivalent)

**References:** It is expected that you will prepare your talk **mainly** from the original references. The number of references required will vary depending on the chosen topic, but a “ballpark” number would be 10.

**Evaluation:** All seminars will be worth 25 marks and will be marked as indicated below:

**Test # 3 will be either a take home test or final exam (15 % of Final Grade).** This will depend upon the overall class attendance during student seminars. If the attendance is satisfactory, a take home test will be given to class at the last class Nov 29, 2018 and due on Dec 6, 2018 at 4:00 pm. The take home test will require a (max. 2 pages/single spaced) written response to a question pertaining to Family Therapy (including any course content). Test # 3 is to be submitted to me by e-mail (in PDF format as an attachment and I will confirm receipt)

**Alternatively, if the overall class attendance for student seminars is not satisfactory, Test 3 will be a final exam during the final exam period scheduled by the University of Winnipeg and will be based on the content of the student seminars (15 % of Final Grades).**
